



Landoll Company, LLC Trailer Limited Warranty Statement

Landoll Company, LLC warrants each new Trailer structure manufactured by Landoll Company, LLC to be free from defects in materials and workmanship. This limited warranty is subject to specific exclusions and does not apply to any trailer which has been: 1) subjected to or operated with loads which, at any time, have exceeded the trailer's rated capacity or design limits; 2) repaired or altered outside our factory in any way so as, in our judgment, to affect its stability or reliability; 3) subject to misuse, negligence, accident, or has been operated in a manner expressly prohibited in the instructions; or not operated in accordance with practices approved by Landoll Company, LLC. Trailer structure shall be considered the framework of the trailer (mainframe and/or rear frame weldment, gooseneck weldment and undercarriage weldment), which is fabricated by Landoll Company, LLC.

The sole obligation of Landoll Company, LLC under this warranty shall be limited to repairing or replacing, at its option, in accordance with the schedule below, a defective new Trailer structure which shall be identified to Landoll Company, LLC by way of a Landoll Company, LLC Warranty Claim Form within five (5) years from the date of registration of Trailer. Warranty, expressed or implied, will be denied on any Trailer not properly registered with the Landoll Company, LLC Warranty Department within ten (10) days of the first retail sale. Resale of the trailer does not transfer warranty coverage. Landoll Company, LLC Warranty Staff will identify components listed on a Warranty Claim required to be returned for further analysis. All parts returned to Landoll Company, LLC must be shipped with a Return Materials Authorization (RMA) provided by the Landoll Company, LLC Warranty Staff. Defective components must be returned by the purchaser to Landoll Company, LLC with transportation and freight charges prepaid within thirty (30) days after receipt of the RMA. The examination conducted by Landoll Company, LLC of returned parts shall disclose to its satisfaction the extent the component may be defective.

All labor and parts warranty MUST be authorized by Landoll Company, LLC Warranty Staff. Failure to do so will result in no warranty payment of any kind. Labor will be reimbursed in accordance with published shop rates preapproved by the Landoll Company, LLC Warranty Staff. Time authorized for specific work will be limited, where appropriate, to the hours listed in the Landoll Company, LLC authorized Flat Rate Schedule.

THIS WARRANTY IS EXPRESSLY IN LIEU OF ALL OTHER WARRANTIES OF MATERIAL, WORKMANSHIP, DESIGN, APPLICATION OR OTHERWISE WITH RESPECT TO ANY EQUIPMENT, WHETHER EXPRESS OR IMPLIED, INCLUDING WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, AND OF ALL OTHER OBLIGATIONS OR LIABILITIES ON THE PART OF LANDOLL COMPANY, LLC.

New Trailer Structure Schedule:

Landoll Company, LLC shall bear that portion of the cost of repairing or replacing the new structure of the Trailer found to be defective within a sixty (60) month warranty period prorated on the following basis:

- One (1) Year - 100%
- Two (2) Years - 80%
- Three (3) Years - 70%
- Four (4) Years - 60%
- Five (5) Years - 50%

Bottom Dump, Industrial and Utility Tag Trailer Exemption:

All Bottom Dump, Industrial and Utility Tag Trailers are exempt from the five (5) year structural warranty and carry a twelve (12) month limited structure warranty, due to the rugged and abusive off-road nature in which these units typically operate, and are subject to the Component Schedule below.

Component Schedule:

Components manufactured by the Landoll Company, LLC (other than the Structure) and Components supplied by other manufacturers shall be warrantied under the following schedule:

- I. Coverage 1st Year 100%, Over 1 Year 0% (Parts and Labor): Axles, Suspensions, Landing Gear, Wheels, Rims, Hubs, Rollers and Cam Followers, Hydraulic Components, Hydraulic Cylinders, Air Cylinders and Landoll Company, LLC Components.
- II. Coverage First six (6) Months 100%, Over six (6) Months 0% (Parts and Labor): Slack Adjusters, Air Lines, Springs, Air Bags, Leveling Valves, Bearings, Brake Valves, Paint, Oil Seals, Brake Drums, Shock Absorbers, Wear Plates, Hydraulic Hoses, Wheel Seals and Connections.
- III. **Coverage Tires, Tubes, Kohler and Wabco:** Warranty Claims must be made directly to the vendor.
- IV. **Coverage Wood Components:** 0%
- V. **Coverage Grote Lights:** The physical Grote lights are warrantied for ten (10) years. Labor is covered for one (1) year.
- VI. **Coverage Grote Bumper Harness:** The Grote bumper harness is covered for seven (7) years. All other harnesses are covered for five (5) years provided the harness has not been modified, by anyone, in any way. Labor is covered for one (1) year.
- VII. **Coverage Brand Hydraulics Remote Control:** Brand Hydraulics remote controls will carry a 2-year, parts-only warranty, beginning on the date the trailer is placed in service. This warranty will cover defects in materials and workmanship, when properly installed, operated, and maintained. Warranty will not apply to items subject to alteration, accident, abuse, misuse, or failure to follow Brand Hydraulics instructions for operation and maintenance. Use of Teflon Tape or other sealants will void this warranty.
- VIII. **Coverage Winches: Braden non-worm** drive winches are warrantied for 1 year against defects in material and workmanship, when properly installed, operated, and maintained. The following winches carry warranties, covering cost of parts only, beginning on the date the trailer is placed in service. **Braden worm** drive winches are warrantied for 3 years against defects in material and workmanship, when properly installed, operated, and maintained. **Warn** winches carry a lifetime warranty for mechanical components, when properly installed, operated, and maintained. **Ramsey** winches will carry a 2 year warranty against defects in material or workmanship, when properly installed, operated, and maintained. The following exclusions will apply to all winches: Motors, cables, brakes, normal wear and tear, paint or finish, bushings, seals, gaskets, O-rings, or damage caused by abuse, accident, lack of maintenance, improper installation, or operation.

Trailer Warranty Exclusions:

This warranty does not expand, enlarge upon or alter in any way, the warranties provided by the original manufacturers and suppliers of component parts and accessories. This warranty excludes such parts or accessories which are not defective, but may wear out and have to be replaced during the warranty period, including, but not limited to, light bulbs, brake lining, wood pieces and the like. (Tire Warranties are expressly excluded from Landoll Company, LLC warranty herein.) Purchaser is expected to pay all repairs and replacement costs, in connection with this Agreement, including sales and other taxes immediately upon completion of work performed.

Limitation Of Liability:

Landoll Company, LLC shall not be liable to purchaser for any incidental or consequential damages suffered by the purchaser, including, but not limited to, any commercially reasonable charges, expenses or commissions incurred in connection with effecting cover or any other reasonable expense incident to the delay or other breach of warranty by Landoll Company, LLC, any loss of or damage to any cargo loaded or shipped in or on the Trailer, loss of anticipated profits, transportation expenses due to repairs, non-operation or increased expense of operation costs of purchased or replaced equipment, claim of customers, cost of money, any loss of use of capital or revenue, equipment rental, roadside assistance, or for any special damage or loss of any nature arising at any time for from any cause whatsoever.

Limitation Of Remedy:

In the event of Landoll Company, LLC failure to repair the Trailer subject to the warranty contained herein, the purchaser's sole and exclusive remedy against Landoll Company, LLC shall be for the repair or replacement of any defective part or parts of the Trailer subject to work or repair within the time period and manner set forth herein. This exclusive remedy shall not be deemed to have failed of its essential purpose so long as Landoll Company, LLC is willing and able to repair or replace defective parts in the prescribed manner.
